



FREQUENTLY ASKED QUESTIONS

WHAT IS A BRACKET?

A bracket is comprised of teams that have qualified to participate in the NCAA Men's Basketball Tournament. The single-elimination tournament results in two teams competing in the Championship Game on Monday, April 6, 2026. To fill out your bracket, simply select the teams that you think will win each game during the tournament up to the Championship Game. If you are a basketball novice, you can use either our PICK FOR ME button to fill out your bracket with randomly selected teams or our FAVORITES button to fill out your bracket with the highest-seeded teams.

Brackets must be **activated** to be eligible to win any bracket prize. Activate brackets with a single kiosk swipe March 16 – 22, 2026.

HOW TO EARN BONUS BRACKETS FOR MORE CHANCES TO WIN UP TO ONE MILLION DOLLARS

Everyone gets one free bracket to submit online and activate on property. However, participants can earn bonus brackets through rated play. Earn one bonus bracket per day, March 3 – 12, by earning a minimum of 200 same-day base points. Limit five (5) bonus brackets per player.

WHAT IS A \$100,000 PROP CARD?

The Prop Card is a 25-question quiz about the Semi-Final and Final Championship games played Saturday, April 4 and Monday, April 6, 2026. Try to predict the answers to the Prop Card questions by clicking on the answers you think will be correct.

Prop Cards must be **activated** to be eligible to win any prop card prize. Activate prop cards with a single kiosk swipe, **Friday, March 27 – Wednesday, April 1, 2026**.

HOW TO EARN BONUS PROP CARDS FOR MORE CHANCES TO WIN UP TO \$100,000

Everyone gets one prop card to submit online and activate on property. However, participants can earn bonus prop cards through rated play. Earn one bonus prop card per day, March 19 – 26, by earning a minimum of 200 same-day base points. Limit five (5) bonus prop cards per player.

DO I NEED TO BE PRESENT FOR THE CHAMPIONSHIP GAME DRAWING?

Yes, you must be present for the Championship Game Drawing on Monday, April 6, 2026, immediately following the Championship game. Swipe to activate your entries at a promotional kiosk beginning at 5:00 PM. Good luck winning a share of \$6,000 Cash and Freeplay!

WHAT ARE THE BRACKET LEADERBOARD PRIZES?

The prize for submitting and activating a perfect bracket in the Million Dollar March Mania promotion is \$1,000,000 cash.



There are additional prizes for the best Week 1, Week 2 and overall season long bracket prizes.

PROMOTION RULES

\$1 Million March Mania - March 3 – April 10, 2026

Club Sol members can participate in the \$1 Million March Mania promotion March 3- April 6, 2026, for a chance to win \$1,000,000 and/or \$100,000 cash, based on Men's college basketball games. Club Sol Members can get one free (online) bracket on Sunday; March 15 and one free (online) prop card March 30. Club Sol members can earn additional brackets and prop cards during the promotions with an active email address and by logging into the March Mania player Portal for a chance at Bracket Leaderboard and Prop Card prizes. Club Sol members also can play free daily online games, win drawing entry tickets, and have a chance to be a part of the finale drawings following the game on April 6, 2026, to win a share of \$6000 in cash and prizes. Bracket and Prop card prizes can be claimed until April 10, 2026.

How to Play:

1. March 3- April 5: Access the \$1,000,000 March Mania Portal
2. Sign up is free
3. Check emails for updates, check online portal for bracket and prop card standings
4. Play daily online games on the portal, Swipe daily at casino of the Sun or Casino Del Sol for free entry tickets
5. Every 200 Slot/table points is an additional entry ticket
6. Join the Grand Finale Drawing on April 6, 2026 following the game

**Bracket(s) are online in the player portal- Participants can fill in their predictions for the winners of each game.*

**Prop Card(s) are online in the player portal- Participants can fill in their 25 answers for the semi-final and championship game questions*

**Leaderboard(s) can be viewed online, for week 1 and 2 games and Overall- Best performing activated brackets; activated prop card results*

RULES:

1. Must be at least 21 years of age to participate (valid proof of age required). If selected participant is not a U.S. citizen, a current passport or alien registration card is required.
2. Must be or become a member of Club Sol to participate, membership is free.
3. Must access game online to participate on compatible device. Access is free with a valid email.
4. One free bracket entry per Club Sol member for the duration of the promotion March 15-18.
5. Submissions of all brackets online March 15-18, 11:59 PM AZ time zone.
6. One Additional bracket entry for 200 table/slot base points, earned March 3-12, 2026. Limit 5 bonus brackets across all gaming
7. March 16- 22 participants must activate brackets by swiping at a kiosk on property
8. Bracket Leaderboards post online: March 23, 30, and April 7, 2026. Winners must claim prize at Club Sol, any time before the next leaderboard posts at Club Sol by 10pm. Last leaderboard winners must claim before April 10th before 10pm.



9. Bracket Scoring: Each correctly picked winner of a tournament game will award bracket point(s). The brackets with the most points at the end of the tournament will win. Bracket points per win are as follows: a.) Round of 64: 1 point per each correct winning team. b.) Round of 32: 2 points per each correct winning team. c.) Round of 16: 4 points per each correct winning team. d.) Round of 8: 8 points per each correct winning team. e.) Round of 4: 16 points per each correct winning team. f.) Championship: 32 points for selecting the national champion.
10. This tiebreaker rule will apply to all ties other than a tie for perfect brackets: In the case of a tie between players' brackets, the winner determined by date and time of submission. The player with the earliest time of submission deemed the winner. Example: Two brackets total 52 points each, one submitted at 5:30 PM on March 15, 2026, and the other at 11:50 AM on March 16, 2026. The earlier of the two (5:30 PM, March 15, 2026) will be declared the winner. In the event of a submission-time tie, the prizes combine and split equally.
11. This tiebreaker rule will apply to all ties for perfect brackets: There is a maximum of one (1) prize of \$1,000,000 cash available. In the case of two or more players submitting a perfect bracket and meeting all eligibility requirements, the \$1,000,000 prize splits equally among all winners, across all entities and contests participating in the insurance pool. 14. March 27- April 1: Participants must activate prop cards by swiping at a kiosk on property
15. Finale Championship Drawing on April 6 immediately following the game.
16. ALL entries must be activated at Casino Del Sol kiosks on Monday, April 6 starting at 5pm
17. All freeplay prizes valid 7 days from issuance, freebet available upon request.
18. Odds of winning dependent upon number of entrants who participate.

Regarding improper conduct, the user will, in particular:
